2 THE UPDATE AGREEMENT'S CONDITIONS

The Update Agreement only covers the licensee, who has the legal right to use AMC Software in accordance with the EULA.

Updates and new versions of AMC Software will continuously be released by AMC and will be made available, as will current user manuals and other forms of documents, which will also be continuously updated.

The Update Agreement can only be drawn for AMC Software as stipulated in the License Agreement and not for parts thereof.

Unless otherwise stipulated in existing conditions, the AMC End User License Agreement applies also to the Update Agreement, in terms of liability, new versions etc. that the licensee receives in accordance with the existing agreement.

3 FREQUENCY AND CONTENTS OF THE UPDATE AGREEMENT

AMC will continuously strive to further develop its software, including correct faults and inexpediciencies as well as altering the programs so that these are compatible with new versions of a third party's software, including products.

As AMC has no influence on a third party's software, it is not possible for AMC to guarantee that its software will always be compatible with new versions, releases etc. of a third party's product, but AMC will strive to produce updates simultaneously with releases within a third party's software.

Further development and alterations done by AMC will take place based on the standard version of AMC software, and it will therefore not always be possible to take alterations and adjustments made by the licensee into consideration. This applies even if alterations and special adjustments were made by AMC.

4 FEES AND PAYMENT

The fee for the Update Agreement is configured on the current AMC price list for the time in question.

The update agreement is included the price given for the fee of using the actual banks and or bank accounts.

5 PRECAUTIONARY MEASURES WHEN IMPLEMENTING THE UPDATE AGREEMENT

It is suggested that the licensee follow all of AMC's verbal and written guidelines when implementing updates. There are no other services besides the delivery of updates included in the update fee.

6 UPDATE LIABILITY LIMITATIONS

In regard to the implementing of new versions, updates, patches, etc.; see existing Update-Agreement, AMC can by no means guarantee that the licensee will be able to use sent updates fully and without difficulty if changes have been made in the software's application logic by the licensee or a third party.

AMC does not guarantee compatibility between versions, updates, etc. or their ability to function properly including consequences these may have on special alterations. Furthermore, the End User License Agreement applies to this area as well.

7 LENGTH AND TERMINATION CONDITIONS FOR THE AGREEMENT

The Update Agreement is in effect until it terminated by one of the parties. Both parties can with a written notice terminate the Up-date Agreement at least 3 months before the expiration of a subscription period.

If the Update Agreement is not terminated with at least 3 months' notice before the end of the update period, the agreement will automatically be continued with another update period as long as the licensee is subscribed for bank and or bank accounts according to the then-current pricelist or otherwise agreed in writing.
